PANJ ENCOURAGES ALL MEMBERS AND OUR FRIEND'S TO CONTACT LEGISLATORS

Governor Christie wants to force New Jersey public workers to pay much more for health coverage. His proposed huge premium hike could cost working families more than \$6,000 a year. Proposals currently under consideration in the State Legislature miss the basic point that we should negotiate health insurance options not play politics.

PANJ believes the answer to New Jersey's budget crisis lies in negotiating real solutions, not to blame hardworking State employees for these problems. Please reject this push to legislate health care and send New Jersey backwards in living standards and public health. Under Gov. Christie's proposed new legislation, thousands of PANJ members and their families will pay much more each year for health care coverage. Lower quality health care plans lack preventative care and affordable medicines that existing health plan include. This will cost the state more money because workers are diagnosed later and get sicker.

PANJ has determined as well that we must stand alongside the NJ PBA and NJ FMBA as well as the other State Association's to protect our pension rights. Specifically, for us this would be the N. J. Public Employees Retirement System (PERS) as we face great danger's and risks in dealing with the worst of over 150,000 adult and juvenile offenders and other court users, in one job function or another that we hold in the Judiciary. Further, PANJ believes that sick time pay and pay-out accumulation for same at the time of retirement should be addressed through the collective bargaining process.

It is important to be aware that these proposals include mandating up to a total of a 30% premium contribution to maintain our medical coverage and pension's for all current employees and future retirees with less than 25 years of service.

Call the Governor and your Legislator's today and tell them how you feel about the attacks against you and your negotiated contracts. Your legislators need to hear from you that the answer to New Jersey's budget crisis is in negotiating real solutions, not by blaming hardworking New Jersey families, many of whom are also State employees. Tell them respectfully that health benefits are a matter for State collective bargaining and not for the Legislature to mandate. If you have called your legislator already then please do so again.
