PANJ Elections 2022

As per the PANJ Constitution, Elections for the Executive Board will be held this year.

Anyone interested in running for a position on the Executive Board will need to submit to the American Arbitration Association no later than September 16, 2022, at least one hundred (100) nomination signatures of Members in good standing. Nomination petitions received after the September 16, 2022 deadline will not be considered.

Nomination petitions may be mailed; emailed to Maria Landi (LandiM@adr.org) or faxed (215-732-5002) to the American Arbitration Association; 230 South Broad Street, Floor 12, Philadelphia, PA 19102.

No member shall be eligible to be nominated or hold any office in PANJ unless he/she is an Active Member in good standing of PANJ and has been an Active Member in good standing for a period of three (3) years immediately prior to the election.

Furthermore, in order to qualify for the offices of President, First Vice President Case-Related Professional Unit, First Vice President Supervisors Unit and Second Vice President, the member must adhere to the additional conditions found in the Constitution.

The Nomination signatures may be obtained from an Active Member in good standing from either the Line or Supervisors Unit throughout the state.

Counting of the Nomination petitions will be conducted on or about September 16, 2022. After the Nominations petitions are counted and certified, the Nominations/Election Committee will then place the names of those individuals on the ballot for their regions and units.

Ballots will then be mailed on or about October 17, 2022. More information will be forwarded, so that all Active Members in good standing as of August 1st, 2022, will be able to participate in the election.
