Teen dating violence is virtually an epidemic. One in five teens in a serious relationship report having been hit, slapped, or pushed by a partner. Forty percent of girls ages 14 to 17 report knowing someone their age who has been beaten or hit by a boyfriend. Thirty percent of murdered teenage girls are killed by current or former partners. This course will examine the basics of teen dating violence. Participants will gain an understanding of the warning signs and ways to advocate for a teen victim. We will discuss the tensions between mandatory reporting requirements and confidentiality. Participants will receive resources and other materials they can use when working with teen victims, their families and communities.

## <u>Developmentally Disabled Offenders: What Every Probation Officer Needs to Know About Supervising Adults and Juveniles with Developmental Disabilities</u>

10% of the offender population has a developmental disability and for juveniles, over 50% of juveniles in custody have a developmental disability. Many more are convicted or adjudicated and placed on probation. Supervising people with cognitive limitations, like Autism Spectrum Disorder, raises serious challenges. Developmental disabilities can be confused with mental illness or go unnoticed by police, courts, attorneys and criminal justice professionals. How do you identify the disability and then how do you access services that can help them comply with conditions of probation? What are the DDD and the DCF and how do they interact with the Courts on behalf of their clients? How do you communicate with someone who has difficulty processing what you say and who has difficulty with expressive language? This presentation will provide an overview of intellectual and developmental disabilities, tips for interacting successfully with this population and ways to locate and obtain needed services.

#### **Human Trafficking**

To address the problem of trafficking of humans in New Jersey, the Attorney General and the Division of Criminal Justice (DCJ) have convened the New Jersey Human Trafficking Task Force comprised of state and federal law enforcement agencies, state regulatory departments, advocacy groups, and social service providers. The Attorney General and DCJ are committed to training and assisting law enforcement in methods of identifying victims and signs of trafficking to disrupt and interdict this activity. The Attorney General and DCJ recognize the need to coordinate law enforcement efforts and to take a multi-disciplinary approach in addressing the needs of victims of all forms of human trafficking. Providing law enforcement with information and education on trafficking and trafficked victims, together with a collaborative, coordinated response to victims' needs, should increase the ability of federal and state prosecutors to successfully prosecute individuals who engage in trafficking of persons. This is an introductory training that will provide a basic understanding of human trafficking, the crime and its' victims. We will also discuss why New Jersey is a prime location for human trafficking and what New Jersey is doing to combat this criminal activity.

## Autism/Aspergers, Sex, and the Law

The result of previous research from the 1970's, along with media representation, has perpetuated the myth that individuals with Autism Spectrum Disorders (ASD) are not interested in sex or are asexual. Recent research acknowledges that individuals with ASD are no less interested in sex, however are often unaware of appropriate sexual interactions. Due to their learning styles and social deficits they may be at risk for sexual abuse or incarceration due to inappropriate sexual activity in public or toward others.

This presentation reviews current research and provides correlations to the presenter's caseload highlighting the need to educate criminal justice professionals of the unique reasons why individuals with ASD enter the criminal justice system as both victims and offenders in the area of sexual offenses. Once in the system their communication and social deficits may lead to conflict/confusion with probation officers, and hinder accessing appropriate resources.

## **Understanding Mental Health and De-Escalation Techniques**
